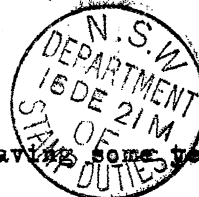


re STEPHEN KERRISON DECEASED

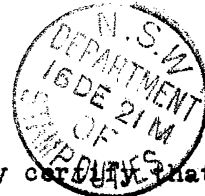
